Born in 1967, André van Dokkum completed secondary school at 't Loo in Voorburg in 1986. He studied physics at Leiden University from 1986 to 1988 (propedeutic diploma 1987). From 1988 until 1993 he studied cultural anthropology, also at Leiden University (doctorandus diploma 1993), graduating on an empirical study about international rural labour migration to The Gambia, supervised by dr. G. Hesselning (fieldwork report published by Leiden University), and on a theoretical study about culture, rationality and logic, supervised by dr. F. Tjon Sie Fat (reworked thesis chapter published in *Current Anthropology*). Thereafter he had several jobs within the fields of tourism and development cooperation, amongst which the Dr. Eduardo Mondlane Foundation (EMS) in Amsterdam, where the origin of the present thesis lies. From 1997 until 2009 he was at the Foundation for Theoretical Research in Anthropology (STOA) in Leiden, under the leadership of dr. J. Windmeijer and dr. D. van Oosterhout, where part of the theory used in this thesis was developed. In the period 2004-2008 he was a member of the editorial board of the *Graduate Journal of Social Science*, an academic periodical devoted to interdisciplinary research within the social sciences. In the period 2007-2008 he worked at the African Studies Centre in Leiden, editing two books together with prof.dr. G.J. Abbink. Thereafter mostly based in East-Asia, he continued working occasionally as an editor and carried out the research project of the present thesis under supervision of prof.dr. G.J. Abbink and dr. M.P. Meneses. He is married to dr. Melody Chia-Wen Lu.
